The City Council meeting was held with in-person attendance and others joined the meeting via phone conference.

Meeting called to order by Acting Mayor Moore at 6:00 P.M.

<u>Library Board Appointment</u> – Mayor Moore would like to appoint Marcia Puckett to the Library Board to fill the unexpired term of Sarah Hallas. This term will expire May, 2023. Mayor Moore declared motion carried and Resolution No. 21-0112-369 approved and duly adopted.

<u>Discussion Concerning Fees at Maple Hill Cemetery</u> – The Council discussed language changes that are needed in the ordinances concerning the cemetery. The fees were also discussed. It has been many years since fees have been raised for the purchase of lots, grave openings, etc. Attorney Rice has been instructed to make revisions to the cemetery code of ordinances to reflect fee increases as well as language changes. This will be brought back to Council for approval.

<u>Discussion Concerning Customer Connection to Sewer Lines</u> – Mayor Moore told the Council that it is the resident's responsibility for paying for connection to the city sewer or problems with the sewer from the house to the sewer main. Many of the mains are located in the middle of the roadway. In a few areas of town, the sewer main is down the road quite a way from the residence. Alderman Lisenbee feels the customer shouldn't be responsible for paying all of the cost if the sewer main is not close to the residence but feels the city should be responsible for any associated costs. Mayor Moore felt this could be quite costly for the city. Alderman Barbre stated he is not in favor of changing our current practice. Mayor Moore asked the Water and Sewer Committee to meet concerning this issue and bring a recommendation back to Council. Those on the committee are Alderman Lampley, Alderman McGill, and Alderman Coale.

<u>Miscellaneous</u> – A few months ago we entered into a Leachate Agreement with Republic Services. Mayor Moore reported that last month we treated 270,000 gallons of leachate at a cost to Republic of approximately \$8,000. This was income to the City because of the recent leachate agreement between the City and Republic Services.

Executive Session – Alderman Stahl made a motion, seconded by Alderman Coale to go into Executive Session to discuss Section 2(c)(23) – discuss contracts relating to the purchase, sale or delivery of electricity or natural gas and Section 2(c)(21) – discuss minutes of closed session meetings.
