Meeting called to order by Mayor Gary Moore at 6:00 P.M.

Recognition of Retired Police Officer – Sergeant Silas Eckleberry has retired from the Fairfield Police Department. Police Chief Colclasure stated that Sergeant Eckleberry has worked for the department beginning May 10, 1989 and retired June 28, 2024. He has served in many areas of the department including the drug task force, sergeant, and assistant chief. Mayor Moore presented a plaque to Silas and thanked him for his many years of service to our city.

Proclamation for “Dolly Parton Imagination Library Day” – Dr. Jill Andrews told the Council about the launch of a Dolly Parton Imagination Library program for our Wayne County children

and the benefits to children that learn to read. Mayor Moore read a proclamation in support of this program.

Approval of Airfield Pavement Maintenance & Pavement Markings Project – Airport Manager Travis Williams told the Council about the pavement maintenance and markings project. The total cost of the project is expected to be about \$230,044 with a 5% local share of \$11,502. A motion was made by Alderman Dewey Eckleberry, seconded by Alderman McGill to approve this project.

Award the Bid for Street Maintenance Project – We plan to do more work on Airport Rd., Frontier Drive, and Ferrington Farm Road. The only bid received was from Mt. Carmel Stabilization in the amount of \$30,631.68. A motion was made by Alderman Stahl, seconded by Alderman McKibben to approve this bid. This cost of this project will be paid out of MFT Funds.

Agreement in Regard to Reimbursement of Police Officer or Firefighter Training, Certification & Equipment Costs – Mayor Moore and Attorney Rice presented this agreement to the Council. This agreement states that if an individual is hired as a police officer or firefighter they must reimburse the city for any costs of their training, certification, and equipment costs if they leave before completing three years of service. Alderman Reeve made a motion, seconded by Alderman Stahl to approve this agreement.

Hiring of Police Officers – Mayor Moore told the Council that we need to hire some additional individuals to serve on the police department. He asked for Council approval to hire four from the current eligibility list. A motion was made by Alderman Dewey Eckleberry, seconded by Alderman Stahl to approve hiring four police officers for the police department.

Update on the Watershed Program (Lakeside) – A public hearing was held last night about this project and many people attended. Mayor Moore spoke to the Council about the different options that has been presented on this project. The four options are: do nothing; a dry dam costing the city \$160,000; a shallow wet dam costing the city \$1.4 million; and a deep wet dam

costing the city \$1.6 million. These projects are all contingent on funding. Mayor Moore asked for feedback from the residents about what they would like to see the city do. He asked residents to contact either him or their aldermen. Mayor Moore stated he would like to see water back in the lake and he thinks the city could find a way to pay for the project.

Financial Report – Mayor Moore presented the financial report for the month of June.
